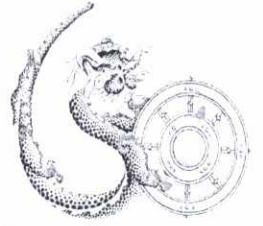

**Executive Order**

This is to inform all concerned that based on the decision of the 93<sup>rd</sup> Lhengye Zhungtshog session and subsequent approval accorded vide letter no. C-3/93/176 dated 8<sup>th</sup> January 2016, the Construction Development Board Secretariat (CDB) has been authorized to train and register arbitrators and maintain a list of trained and certified arbitrators. Arbitrators trained and certified by the CDB or in partnership with recognized institutions will be registered automatically. All arbitrators certified by institutions other than CDB, wishing to register with CDB may do so with immediate effect on production of requisite testimonials to the Construction Arbitration Facilitation Center of the CDB.

The registered list of arbitrators will be made available on CDB website at [www.cdb.gov.bt](http://www.cdb.gov.bt) and displayed in the conference hall of CDB office.

The Lhengye Zhungtshog, has also designated CDB as the facilitator of construction related arbitration until such time the Alternative Dispute Resolution (ADR) Center is established. Therefore, CDB will continue to facilitate arbitration related to construction following the provisions of the Alternative Dispute Resolution Act 2013. The parties wishing to avail of this service may do so upon submission of an application in the prescribed form and payment of arbitration fees of Nu. 15,000.00 which is the approved revised fees. If the application is found to warrant arbitration, the parties will be advised to appoint their choice of arbitrators from the list maintained by the CDB. Since this practice is an institutional arbitration, the arbitral award of the Arbitral Tribunal will be forwarded to the parties under the seal and signature of the CDB for implementation.

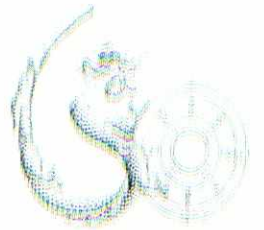
