THE PARLIAMENTARY ENTITLEMENT (AMENDMENT) ACT OF BHUTAN 2014

An Act to amend the Parliamentary Entitlement Act of Bhutan 2008;

Parliament of the Kingdom of Bhutan do hereby enact the Parliamentary Entitlement (Amendment) Act of Bhutan 2014 on the 11th Day of the 10th Month of the Wood Male horse Year of the Bhutanese Calendar corresponding to the 2nd Day of December 2014 as follows:

Title, Commencement and Extent

- 1. This Act shall:
 - a) Be called the Parliamentary Entitlement (Amendment) Act 2014;
 - b) Come into force on the 8th Day of the 1st Month of the Wood Female sheep Year of the Bhutanese Calendar corresponding to the 26th Day of February 2015; and
 - c) Extend to whole of Bhutan.
- 2. In the Parliamentary Entitlement Act of Bhutan 2008, hereinafter referred to as the Act, New Section 8A is inserted as:

The Salary, allowances and other benefits of the Members of Par liament shall be paid with effect from the day of the declaration of the election result or in case of eminent members, from the day the Druk Gyalpo grants the nomination Kasho till the seat becomes vacant.

3. In the Act Section 9 is amended as:

The salary, allowances, benefits and other emoluments of the Members of Parliament shall not be reduced during one's term of office

4. In the Act Section 11 is amended as:

Deputy Speaker of National Assembly and the Deputy Chairperson of the National Council shall receive salary slightly higher than the Members of Parliament for their additional responsibility.

5. In the Act Section 16 is amended as:

When a Member of Parliament performs a journey outside the country in discharge of duties, he or she shall be entitled to traveling and other allowances in accordance with the Parliamentary Entitlement Rules and Regulations.

6. In the Act Section 17 is amended as:

A Member of parliament shall be entitled to executive class while traveling by air or train.

7. In the Act Section 20 is amended as:

Transport

Every Member of Parliament shall be provided with:

- a) A lump sum amount to purchase a vehicle;
- b) Exemption of customs duty and sales tax for purchase of a vehicle not exceeding 3000 cc;
- c) A monthly driver allowance; and

d) A monthly fuel and maintenance allowance.

Such proportionate amount as remaining upon his or her retirement/resignation before the completion of the five-year term or termination from service shall be reimbursed to the Government. The lump sum amount and the monthly allowance shall be given in the Annexure

8. In the Act Section 30 is amended as:

Eligibility Criteria for Gratuity

A Member of Parliament upon retirement on completion of his or her term or illness or resignation or death before the term or premature dissolution of the National Assembly or in the event of a motion of no confidence vote against the government being passed in the National Assembly or by the declaration of the Supreme Court shall be entitled to such amount of gratuity as provided for in the Parliamentary Rules and Regulations.

9. In the Act Section 31 is amended as:

The amount of gratuity shall be as given in Annexure. However, no gratuity shall be payable if a Member's service is terminated.

10. In the Act Section 33 is amended as:

Gratuity shall be sanctioned to a Member of Parliament by the respective Secretary Generals of the House of the Parliament in accordance with the Parliamentary Entitlement Rules and Regulations.

11. In the Act Section 36 is amended as;

Family of an expired Member of Parliament shall be entitled to traveling allowance in accordance with Parliamentary Entitlement Rules and Regulations for proceeding to their home town.
