Terms and Conditions for purchase of Computers:

- 1. Bids in sealed quotation shall be submit on or before 27 January 2016 on or before 12 noon after which no bids will be accepted. The Tender Committee shall open the bids on the above mentioned date and time. Participating Bidders may attend the opening of the bids.
- 2. All bids must be accompanied by valid trade license issued by the Ministry of Economic Affairs (then the MoEA)
- 3. Any bid received after the deadline shall be declared "late and rejected" and shall be returned unopened to the bidder.
- 4. Tender shall be submitted along with earnest money, which shall be at the rate of 2% of the total tender value in the form of cash Warrant/Bank draft in favour of Attorney General, Office of the Attorney General, Thimphu. Tender bids submitted without earnest money shall be rejected. Earnest money shall be refunded on the finalization of tender after.
- 5. All the rates are to be quoted in Ngultrum.
- 6. No bid shall be withdrawn after the submission till the opening of the bids.
- 7. The rates quoted for the equipment shall be valid till the completion of delivery of the goods.
- 8. The tender need not necessarily go to the lowest bidder, but to the lowest evaluated Bidder.
- 9. Successful bidder(s) selected to supply the equipment shall be required to furnish security deposit, which shall be at the rate of 7% of the purchase orders.
- 10. The Office of the Attorney General reserves the rights to vary the quantity to the extent of 10% on the same terms and conditions.

- 11. The equipment to be supplied shall conform with the specification and subject to testing as may be necessary. Bidders should bid strictly against those Makes and Models specified in the Bill of Quantities and Price Schedule. No deviation or substitution of Make/Models will be accepted on whatever grounds. Any deviation or substitution in the Makes/Models will automatically render the bids as disqualified.
- 12. Full delivery of item shall be completed within **45 days** from the date of Supply Order, failing which the security deposit shall be forfeited and the supply order shall be awarded to the second lowest evaluated bidder.
- 13. If the selected bidder fails to supply the full quantity ordered, the purchaser shall recover, as liquidated damages, the difference between the contracted rates and the actual price paid by the purchaser, for the quantity not supplied.
- 14. All equipments quoted should be accompanied by technical literature wherever applicable. Full technical description of the product offered, supported by catalogues, booklets etc. should also be given with the tender.
- 15. All the equipment supplied should have proper and authentic certificate. The details of the after sales services provided by the bidder should also be given in the tender.
- 16. The supplier is required to ensure the installation and operation demonstration of the equipment supplied.
- 17. The supplier must ensure that the standard accessories included with the equipment by the manufacturer but are not specified in the specification are supplied intact.
- 18. Bidder must conform that all the goods supplied shall carry the standard international warranty accorded by the respective manufacturers and that they accept to remedy all warranty claims within the warranty period free of cost to the Office of the Attorney General. Warranty coverage must be clearly specified.
