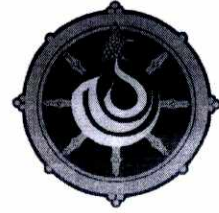

- a. The sealed bid should be addressed to “Hon’ble Attorney General, Office of the Attorney General, Thimphu”.
- b. The submission of the sealed bid is opened w.e.f October 01, 2021 at 09:00 AM to October 21, 2021 at 05:00 PM as per section 11.18 of the Standard Operating Procedure (SOP) for Property and Judgment Enforcement Division (PJED), Office of the Attorney General.
- c. The bidder should come in person and submit the sealed bid form to the Offtg. Chief Attorney, PJED, OAG, on or before October 21, 2021 at 05:00 PM.

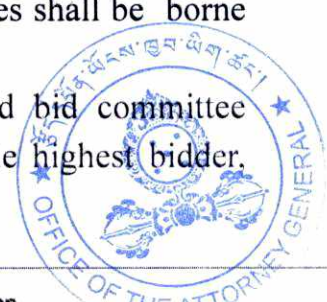


- d. The bidder should mention the bid amount in both figure and word. If both the figure and word aren't mentioned, the bid shall remain cancelled.
- e. The sealed bid shall be opened on October 22, 2021 at 10:00 AM in the OAG's conference hall.
- f. The bidder may present himself/herself during the bid opening to ensure transparency and accountability through **zoomlink** which shall be shared by this office on the day of opening the sealed bid.
- g. The bid opening shall be carried out by a committee from the Office of the Attorney General.
- h. The bid property shall remain disposed off only if the "**reserve fixed price**" is met as per section 11.17 of the SOP, PJED. If not, the bid property remains "undisposed".
- i. The successful bidder shall make the payment of bid amount (in full), after deducting whatever sum is payable within "**seven working days**" after successful auctioning in favour of "Office of the Attorney General, Thimphu" through cheque or cash whichever is convenient.

Provided that the bidder next-in-line shall be eligible to take over the bid property if the successful bidder fails to make the payment within seven working days.

- j. The vehicle shall be handed over to the successful bidder as is-where it's basis only after the successful bidder makes the full payment of bid amount.
- k. Once the bid property is successfully disposed off and hand-taking executed, the Office of the Attorney General shall not be liable for maintenance of the vehicle and other associated charges thereunder.
- l. The Office of the Attorney General (OAG) shall facilitate the transfer of ownership but the payment shall be borne by the successful bidder. However, the payment of pending fines and penalties shall be borne by the OAG from the auction proceeds.
- m. If the bid property remains undisposed, the sealed bid committee reserves the right to dispose off the property to the highest bidder.

- even if the reserve fixed price is not met, as deemed speedy and would save the cost of the Government.
- n. In case two or more bidders have quoted the same price and turns out to be the maximum bid amount, then the bid shall be awarded to the bidder who first submitted the bid to the OAG.
- o. The bidder, after signing on these terms and conditions, is deemed to have agreed to abide by it accordingly.
